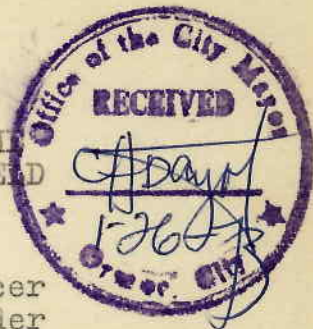

RESOLUTION NO. 18

A RESOLUTION ENDORSING THE URBAN DEVELOPMENT PLAN OF ORMOC
CITY AS SUBMITTED BY THE OFFICE OF THE CITY ENGINEER

"WHEREAS, the Officer-in-Charge of the City Engineer's Office has shown this august Body his 2nd Indorsement dated January 24, 1973, to the Honorable City Mayor, covering the Ormoc City road map indicating the boundaries of the city's projected urban development plan involving an area of from 14 to 15 square kilometers extending from the coastal barrios of and between Ipil and Nauangan northward, with which is suggested that in the development of all barrios each barrio proper be doubled in its present area to provide room for expanding and progressing rural communities, pursuant to Letter of Instruction No. 46 of His Excellency, the President of the Philippines, dated December 7, 1972, as enjoined by the Honorable Secretary of Agrarian Reforms;

"NOW, THEREFORE, on motion of Councilor Marquez, seconded by Councilor Kangleon;

"RESOLVED, to endorse the urban development plan of Ormoc City as submitted by the Office of the City Engineer;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Secretary of Agrarian Reforms, Malabon, Rizal; the Agrarian Reform District Officer, Patria de Cebu, Cebu City; the Regional Director of Agrarian Reform, Cebu City; and the City Engineer, Ormoc City;
