RESOLUTION NO. 19

A RESOLUTION AUTHORIZING THE CITY ENGINEER TO AVAIL HIMSELF OF THE SUM OF P10,000.00 OUT OF ITEM NO. 7 OF CAPITAL OUTLAYS FOR FEEDER ROADS FOR THE COMPLETION OF THE ORMOC-TUNGONAN FEEDER ROAD CONSTRUCTION.

"WHEREAS, the Officer-in-Charge of the City Engineer's Office in his communication dated January 24, 1973, has reported that very recently representations were made by a Volcanology Commission team with his office on the imperative necessity of finishing the Ormoc-Tungonan feeder road to facilitate their hauling of light and heavy scientific equipment to the NPC geothermal development site at Tungonan Hot Springs National Park, for which he requested that his office be granted the authority to avail himself of the sum of P10,000.00 out of Item No. 7 for feeder roads under Capital Outlays in the current city budget;

"NOW, THEREFORE, on motion of Councilor Aviles, seconded jointly by Councilors Kangleon and Porcadilla;

"RESOLVED, to authorize the City Engineer to avail himself of the sum of P10,000.00 out of Item No. 7 for feeder roads under Capital Outlays in the current city budget, said sum to be made available for the completion of the Ormoc-Tungonan feeder road construction;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and the City Engineer, all of Ormoc City;

"CARRIED UNANIMOUSLY."




