RESOLUTION NO. 19

A RESOLUTION AUTHORIZING THE OFFICER-IN-CHARGE OF THE CITY
ENGINEERING DEPARTMENT TO AVAIL HIMSELF OF THE SUM OF
P20,000.00 IN ITEM NO. 7 OF CAPITAL OUTLAYS FOR FEEDER
ROADS FOR THE COMPLETION OF THE ORMOC-TUNGONAN FEEDER
ROAD CONSTRUCTION.

"WHEREAS, the Officer-in-Charge of the City Engineer's
Office in his communication dated January 24, 1973, has re-
ported that very recently representations were made by a
Volcanology Commission team with his office on the impera-
tive necessity of finishing the Ormoc-Tungonan feeder road
to facilitate their hauling of light and heavy scientific
equipment to the NPC geothermal development site at Tungo-
nan Hot Springs National Park, for which he requested that
he be granted the authority to spend the sum of P20,000.00
appropriated in the current city budget under Capital Out-
lays, more particularly, Item No. 7 for feeder roads;

"NOW, THEREFORE, on motion of Councilor Aviles, second-
ed jointly by Councilors Kangleon and Porcadilla;

"RESOLVED, to authorize the Officer-in-Charge of the
City Engineer's Office to avail himself of the sum of P20,
000.00 in Item No. 7 of Capital Outlays for feeder roads
for the completion of the Ormoc-Tungonan feeder road cons-
truction;

"RESOLVED, FURTHER, to furnish a copy of this resolu-
tion each to the City Treasurer, the City Auditor, and the
City Engineer, all of Ormoc City;
