RESOLUTION NO. 20

A RESOLUTION REVERTING THE AGGREGATE SUM OF FOUR THOUSAND FIVE HUNDRED FIFTY PESOS (P4,550.00) FROM OUT OF SALARY SAVINGS AND UNEXPENDED BALANCE OF BUILDING RENTALS OF THE AGRICULTURAL AND VETERINARY EXTENSION SERVICES TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE CONSTRUCTION OF A SWINE AND POULTRY HOUSE AT THE CAGBUHANGIN NURSERY.
