RESOLUTION NO. 21

A RESOLUTION ADOPTING RESOLUTION NO. 316, SERIES
OF 1972, OF THE HONORABLE PROVINCIAL BOARD OF
LA UNION

"WHEREAS, the Honorable Provincial Board of Davao has furnished this august Body for our concurrence and support its Resolution No. 814 dated December 27, 1972, concurring in and adhering to Resolution No. 316 dated August 11, 1972, of the Honorable Provincial Board of La Union, requesting His Excellency, President Ferdinand E. Marcos, to cause the organization of a separate League of Provincial Vice-Governors and City Vice-Mayors of the Philippines, which organization will redound to the economic welfare and progress of the people as envisioned under the New Society;

"WHEREAS, this august Body would like to join the Provincial Board of Davao to concur in and adhere to the reasons of the Provincial Board of La Union for the creation of a separate organization for Provincial Vice-Governors and City Vice-Mayors;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded jointly and unanimously by the Floor Leader and Councilors Kangleon, Mendola, Marquez, Samson and Mejia;

"RESOLVED, to adopt Resolution No. 316, series of 1972, of the Honorable Provincial Board of La Union, and do, as this Body hereby does, request His Excellency, President Ferdinand E. Marcos, to cause the organization of a separate League of Provincial Vice-Governors and City Vice-Mayors of the Philippines for the economic welfare and progress of the people under the New Society;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, Manila; the Honorable Provincial Board of La Union, the Honorable Provincial Board of Davao (Tagum), and His Honor, the Mayor of Ormoc City;

"CARRIED UNANIMOUSLY."
