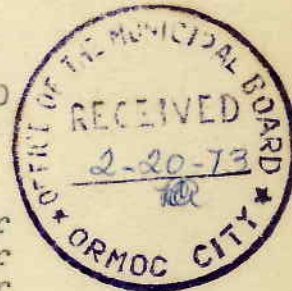

RESOLUTION NO. 22

A RESOLUTION ADOPTING RESOLUTION NO. 1042, SERIES
OF 1972, OF THE HONORABLE PROVINCIAL BOARD OF
BATANGAS

"WHEREAS, this august Body has been in receipt of Resolutions Numbered 453 and 684 of the Honorable City Councils of Oroquieta and Zamboanga, respectively, and Resolutions Numbered 854 and 815 of the Honorable Provincial Boards of Isabela and Davao, respectively, all series of 1972, concurring in and adhering to Resolution No. 1042, series of 1972, of the Honorable Provincial Board of Batangas, which was also adopted by the Honorable Provincial Board of Bukidnon in its Resolution No. 72-768, requesting His Excellency, President Ferdinand E. Marcos, to kindly lift the ban on the implementation of salary increases and/or filling up of vacant positions and creation of new positions as an exception and/or special case for provinces and cities which can well afford to implement the same;

"WHEREAS, this august Body would like to join the Honorable City Councils of Oroquieta and Zamboanga and the Honorable Provincial Boards of Isabela, Davao and Bukidnon in concurring in and adhering to the reasons manifested in Resolution No. 1042, series of 1972, of the Honorable Provincial Board of Batangas, knowing as we do that Ormoc City can well afford to implement salary increases and/or filling up of vacant positions and even creation of new positions as exigency of public service demands;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded by Councilor Samson;

"RESOLVED, to adopt Resolution No. 1042, series of 1972, of the Honorable Provincial Board of Batangas, and do, as this Body hereby does, earnestly request his Excellency, President Ferdinand E. Marcos, to kindly lift the ban on the implementation of salary increases and/or filling up of vacant positions and creation of new positions as an exception and/or a special case for provinces and cities which can well afford to implement the same;

Marcos, Malacañang, Manila; the Honorable Provincial Board of Batangas, the Honorable Provincial Board of Isabela, the Honorable Provincial Board of Davao, the Honorable Provincial Board of Bukidnon, the Honorable City Council of Oroquieta, the Honorable City Council of Zamboanga, and His Honor, the Mayor of Ormoc City;
