RESOLUTION NO. 25

A RESOLUTION REVERTING THE SUM OF TWO HUNDRED FIFTY PESOS (P250.00) FROM OUT OF THE ITEM ON RURAL IMPROVEMENT UNDER AIDS AND TRANSFER OF FUNDS TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION TO THE MAYOR'S DISCRETIONARY FUND FOR MEAL ALLOWANCES OF THE R.S.V.P. TEAM FROM MANILA RENDERING MEDICAL ASSISTANCE IN THE BARRIOS OF ORMOC CITY.

"WHEREAS, the City Health Officer in a communication of February 2, 1972, has, among other things, requested an appropriation of P250.00 for meal allowances of the Rural Service Volunteers of the Philippines (RSVP) Team from Manila who are now rendering medical assistance in the barrios of Ormoc City;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Mendola;

"RESOLVED, to revert the sum of two hundred fifty pesos (P250.00) from out of the item on Rural improvement under Aids and Transfer of Funds, said sum to be made available for supplemental appropriation to the Mayor's discretionary fund for meal allowances of the R.S.V.P. Team from Manila rendering medical assistance in the barrios of Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and the City Health Officer, all of Ormoc City;

"CARRIED UNANIMOUSLY."
