RESOLUTION NO. 27

A RESOLUTION AUTHORIZING THE HONORABLE CITY VICE-MAYOR AND
PRESIDING OFFICER OF THE BOARD TO PROCEED IMMEDIATELY
TO MANILA TO FOLLOW UP URGENT PENDING MATTERS AFFECT-
ING THE CITY OF ORMOC.

"WHEREAS, it has once again become imperative to follow
up important matters affecting the City of Ormoc which are
still pending with the Office of the President and various
departments of the National Government in Manila, foremost
among which is our urgent request to exempt Ormoc City from
Memorandum Circular No. 593, series of 1972, in order that
we can avail ourselves of the P35,000.00 appropriated for
necessary office equipment, furnishings and appliances for
the new City Hall building which is now nearing completion;

"NOW, THEREFORE, on motion of Councilor Porcadilla, se-
conded by Councilor Mejia:

"RESOLVED, to authorize the Honorable City Vice-Mayor
and Presiding Officer of the Board to proceed immediately
to Manila to follow up urgent matters affecting the City of
Ormoc now still pending with the Office of the President
and various departments of the National Government;

"RESOLVED, FURTHER, to furnish a copy of this resolu-
tion each to His Honor, the City Mayor, the City Vice-Mayor,
the City Treasurer and the City Auditor, all of Ormoc City;
"CARRIED UNANIMOUSLY."
