RESOLUTION NO. 31

A RESOLUTION REVERTING THE SUM OF FIVE HUNDRED PESOS (P500)
FROM OUT OF SALARY SAVINGS OF THE POLICE DEPARTMENT TO
BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR
TRUST FUND TO BE DEPOSITED WITH THE PROVINCIAL TREASURY
FOR REPAIR AND MAINTENANCE OF THE CPD TRANSCIVER.

"WHEREAS, the Honorable City Mayor has requested the re-
version of the sum of P500.00 from out of salary savings of
the Police Department to be deposited with the Provincial
Treasury as trust fund for the repair and maintenance of the
transceiver of the Ormoc City Police Department as guaranteed
by the Leyte Law Enforcement Communications System in coope-
ration with the USAID and the Police Commission;

"NOW, THEREFORE, on motion of Councilor Kangleon, second-
ed by Councilor Porcadilla;

"RESOLVED, to revert the sum of five hundred pesos (P500)
from out of salary savings of the Police Department, said sum
to be made available as supplemental appropriation for trust
fund to be deposited with the Provincial Treasury for repair
and maintenance of the transceiver of the Ormoc City Police
Department;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the Honorable Provincial Governor, the Provincial
Treasurer, and the Regional Commissioner, Police Commission,
all in Tacloban City; the City Treasurer and the City Auditor,
both of Ormoc City;
