RESOLUTION NO. 33

A RESOLUTION AMENDING RESOLUTION NO. 9, CURRENT SERIES, BY
REVERTING INSTEAD THE SUM OF P850.00 FROM OUT OF SALARY
SAVINGS OF THE POLICE DEPARTMENT TO BE CONSIDERED A PRO-
PER DEDUCTION AGAINST THE UNCOLLECTED BACK SALARIES OF
PAT. ADELAIDO HERRERA TO PAY THE CLAIM OF HIS COUNSEL,
ATTY. MARCIANO S. DU, IN THE COURT OF FIRST INSTANCE

"WHEREAS, for the satisfaction of the claim of Atty. Mar-
ciano S. Du for services rendered as counsel of Pat. Adelaido
Herrera and in compliance with the alias writ of execution of
the Court of First Instance, Ormoc City, the City Treasurer
has requested the amendment of our Resolution No. 9, current
series, by reverting instead the sum of P850.00 from out of
salary savings of the Police Department to be considered a
proper deduction against the uncollected back salaries of Pat.
Herrera, one-third of which has already been collected;

NOW, THEREFORE, on motion of Councilor Kangleon, second-
ed by Councilor Mandola;

"RESOLVED, to amend Resolution No. 9, current series, by
reverting instead the sum of eight hundred fifty pesos (P850)
from out of salary savings of the Police Department to be con-
sidered a proper deduction against the uncollected back sala-
ries of Pat. Adelaido Herrera, one-third of which has already
been collected, said sum to be made available for payment of
the claim of his counsel, Atty. Marciano S. Du, as per order
of the Court of First Instance in Special Civil Case No. 1127-
O dated January 13, 1973;

"RESOLVED, FURTHER, to furnish a copy of this resolu-
tion each to the City Treasurer, the City Auditor, the Judge
of the Court of First Instance, Atty. Marciano S. Du, and
Pat. Adelaido Herrera, OCPD, all of Ormoc City;
