A RESOLUTION CREATING A SPECIAL COMMITTEE TO PLAN  
FEASIBILITY STUDIES FOR URBAN DEVELOPMENT AND  
AGRICULTURAL INFRASTRUCTURES OF ORMOC CITY

"WHEREAS, in order to avail ourselves of the dollar funding reserves of the National Government it has become imperative that a special committee be created to plan feasibility studies for urban development and agricultural infrastructures of Ormoc City to be composed of the City Engineer as Chairman, together with a representative of the Department of Agrarian Reform as Co-Chairman, and the City Vice-Mayor and City Councilors as Ex-officio Co-Chairmen insofar as their respective council districts are concerned, the City Development Officer as Vice-Chairman, and the City Agriculturist, one Statistician, and one Soil Technologist as Members;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Mendola;

"RESOLVED, to create a Special Committee to Plan Feasibility Studies for Urban Development and Agricultural Infrastructures of Ormoc City to be composed of the following:




