RESOLUTION NO. 36

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO
ACCEPT THE DONATION OF A 228-SQUARE-METER PORTION
OF LOT NO. 2329-A BY THE SPOUSES CARMELITTO RESTAURO
AND ALICIA ZAMORA FOR SCHOOL SITE PURPOSES OF BARRIO
PUNTA AND THANKING THE DONORS FOR THEIR KINDNESS AND
LIBERALITY.

"WHEREAS, after negotiations with the spouses Carmelito Restauro and Alicia Zamora they finally agreed to donate the portion of their Lot No. 2329-A occupied by, and separated by the fence of, the Punta Community School site, more particularly described as: a portion of Lot No. 2329-A (LRC) Psd-140731, Ormoc Cadastre, situated at Barrio Punta, Ormoc City, bounded on the NE. by Lot No. 2322; on the SW. by the Ormoc-Naugangan Road; on the E. the donors' lot; and on the W. by the school site, having an area of two-hundred twenty-eight (228) square meters, more or less, and within the hollow-block fence of Punta Primary School;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded by Councilor Kangleon;

"RESOLVED, to authorize the Honorable City Mayor to accept the donation of a 228-square-meter portion of Lot No. 2329-A, described above, by the spouses Carmelito Restauro and Alicia Zamora for school site purposes of Barrio Punta, and do, as this Body hereby does, thank the donors for their kindness and liberality which will go a long way in the field of education in Barrio Punta, in particular, and Ormoc City, in general;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Mr. and Mrs. Carmelito Restauro, the Barrio Council and the School Principal, Barrio Punta; and the Register of Deeds, the City Treasurer and the City Auditor, all of Ormoc City;
