RESOLUTION NO. 38

A RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF LEYTE TO SELL EQUIPMENT SURPLUS DECLARED AS "JUNK" TO ORMOC CITY GOVERNMENT AND AUTHORIZING THE CITY ENGINEER AND HIS MECHANICAL ENGINEERS TO SELECT THE SURPLUS EQUIPMENT FROM THE JUNK YARD AT TAGLOBAN CITY;

"WHEREAS, the Government of Ormoc City is interested to buy four (4) Thames Trader and some FUZO dump trucks for the City Engineering Office and Bureau of Public Highways from the Provincial Government of Leyte which equipment are surplus and declared as 'junk' in the provincial junk yard at Tacloban City;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Kangleon and Mendola;

"RESOLVED, to earnestly request the Provincial Government of Leyte to sell equipment surplus declared as 'junk' to Ormoc City Government and do, as this Body hereby does, authorize the City Engineer and his mechanical engineers to select the surplus equipment from the provincial junk yard at Tacloban City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Provincial Board, through the Honorable Provincial Governor, Tacloban City; the City Engineer, the City Treasurer and the City Auditor, all of Ormoc City;
