RESOLUTION NO. 39

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE COMMISSIONER OF THE BOARD OF TRAVEL AND TOURIST INDUSTRY TO EXTEND FINANCIAL AID TO ORMOC CITY FOR THE LANDSCAPING AND GENERAL BEAUTIFICATION OF TUNGONAN HOT SPRINGS NATIONAL PARK SO AS TO BOOST TOURISM IN ORMOC CITY AND AUTHORIZING THE CITY ENGINEER TO FOLLOW UP THIS MATTER IN MANILA.

"WHEREAS, to enhance the full development, improvement and beautification of Ormoc City along infrastructural and aesthetic lines, we urgently need financial aid from the Board of Travel and Tourist Industry for the landscaping and general beautification of Tungonan Hot Springs National Park, like for example, the construction of a swimming pool and a rest house, in order to boost tourism in this part of the archipelago;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to earnestly request the Honorable Commissioner of the Board of Travel and Tourist Industry to extend financial aid to Ormoc City for the landscaping and general beautification of Tungonan Hot Springs National Park so as to boost tourism in Ormoc City;

"RESOLVED, FURTHER, to authorize the City Engineer, to follow up this request with the Board of Travel and Tourist Industry in Manila as soon as possible;

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Honorable Commissioner, Board of Travel and Tourist Industry, Greater Manila, and the City Engineer, Ormoc City;
