A RESOLUTION ENDORSING THE COMMENTS AND RECOMMENTS AND RECOMMENTS. THE CITY ENGINEER ON THE ORDER OF THE BUXEAU OF LANDS FOR AMENDMENT OF THE MISCELLANEOUS SALES APPLICATION OF THE LEYTE AUTOBUS ON LOT NO. 1221, CAD. 256, IN THE CITY OF ORMOC.

"WHEREAS, the City Engineer in his 2nd Indorsement dated February 5, 1973, in connection with the order of the Bureau of Lands for amendment of the miscellangous sales application of the Leyte Autobus on Lot No. 1221, Cad. 256, situated in this city, has submitted the following comments and recommendation, to wit:

- '1. A reside tial house owned and occupied by a squarter is constructed near the barbed wire fence of the Leyte Autobus.
- '2) The distance from the residential house office of the Leyte Autobus to the fence is neters, more or less; and
- 3. Motor vehicles entering the area applied face a dead end there being no available T-turn or broking-up space.

'This Office, therefore, interposes no objection to the amended application of the Leyte Autobus; provided, however, that the distance from the said residential house to the fence be reduced to 15 meters to provide for a "T"-turn, so that the total area of the land applied for marked "X" on the plan, be reduced to 400 square meters, more or less.

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Kangleon;

"RESOLVED, to endorse the comments and recommendation of the City Engineer on the Order of the Bureau of Lands for amendment of the miscellaneous sales application of the Leyte Autobus on Lot No. 1221, Cad. Case 256, situated in the City of Ormoc;
