RESOLUTION NO. 41

A RESOLUTION AUTHORIZING THE HONORABLE FLOOR LEADER AND
ACTING PRESIDING OFFICER OF THE BOARD TO SIGN RESOLU-
TION NO. 25 PASSED DURING THE REGULAR SESSION OF FEB-
RUARY 8, 1973, FOR AND IN THE ABSENCE OF THE HONORABLE
VICE-MAYOR AND PRESIDING OFFICER OF THE BOARD.

"WHEREAS, this august Body will remember having passed
during last week's regular session Resolution No. 25 revert-
ing the sum of ₱250.00 from out of the item on Rural improve-
ment under Aids and Transfer of Funds, said sum to be made
available for supplemental appropriation to the Mayor's dis-
cretionary fund for purposes of meal allowances of the RSVP
Team from Manila rendering medical assistance in the barrios
of Ormoc City, which resolution could not be signed by the
Honorable Vice-Mayor and Presiding Officer of this Board in
view of his sudden departure for Manila to follow up impor-
tant pending matters affecting Ormoc City but which resolu-
tion is urgently needed by the City Health Officer in order
that he could be released the amount appropriated for the
purpose;

"NOW, THEREFORE, on motion of Councilor Samson, second-
ed by Councilor Porcadilla;

"RESOLVED, to authorize the Honorable Floor Leader and
Acting Presiding Officer of the Board to sign Resolution No.
25 passed during the regular session of February 8, 1973,
for and in the absence of the Honorable Vice-Mayor and Pre-
siding Officer of the Board;

"RESOLVED, FURTHER, to furnish a copy of this resolu-
tion each to His Honor, the City Mayor, the Honorable City
Vice-Mayor and Presiding Officer, and the Honorable Floor
Leader and Acting Presiding Officer, Municipal Board, all
of Ormoc City;

"CARRIED UNANIMOUSLY."
