

RESOLUTION NO. 42

A RESOLUTION APPROPRIATING THE SUM OF THREE THOUSAND ONE HUNDRED PESOS (P3,100.00) OUT OF THE UNDERESTIMATED REVENUE OR RECEIPTS FROM PRIOR YEAR'S ADJUSTMENT NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS CITY'S SHARE TO PAY TERMINAL LEAVE OF MR. SEGUNDO A. PABENIS, RETIRED CITY AUDITOR.

"WHEREAS, following his retirement as City Auditor effective February 1, 1973, Mr. Segundo A. Pabenis in his communication dated February 12, 1973, has requested an appropriation of P3,100.00 to cover the City's share to pay his terminal leave from July 1, 1973, to December 28, 1973, which amount can be taken from the underestimated revenue or receipts from the prior year's adjustment;

"WHEREAS, after consultation with the City Treasurer, the latter has acceded to the request as the fund is available for the purpose;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Porcadilla and Mejia;

"RESOLVED, to appropriate the sum of three thousand one hundred pesos (P3,100.00) out of the underestimated revenue or receipts from prior year's adjustment existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation as city's share to pay the terminal leave of Mr. Segundo A. Pabenis, retired City Auditor, covering the period from July 1 to December 28, 1973;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Auditor and the City Treasurer, both of Ormoc City;
