RESOLUTION NO. 44

A RESOLUTION REVERTING THE SUM OF FIVE THOUSAND PESOS
(P5,000.00) FROM OUT OF ITEM NO. 6 UNDER (C-26-27)
ENGINEERING AND CITY PUBLIC SERVICES TO BE MADE
AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR INITIAL
EXPENSES FOR ROADSIDE DEVELOPMENT OF ITS NEW OFFICES
AND MOTOR POOL COMPOUND AT THE GOVERNMENT CENTER SITE

"WHEREAS, the City Engineer in his letter dated Feb-
ruary 13, 1973, has requested an initial appropriation of
P5,000.00 for the roadside development of the whole area
of the new engineering offices and motor pool compound at
the Government Center site of Ormoc City;

"NOW, THEREFORE, on motion of Councilor Samson, se-
conded jointly by Councilors Aviles and Mendola;

"RESOLVED, to revert the sum of five thousand pesos
(P5,000.00) from out of Item No. 6 (General Utility Labo-
rers) under (C-26-27) Engineering and City Public Services,
said sum to be made available as supplemental appropria-
tion for initial expenses for roadside development in con-
nection with the construction and development of the new
City Engineering offices and motor pool compound at the
Government Center site of Ormoc City;
