RESOLUTION NO. 47

A RESOLUTION REVERTING THE SUM OF TWO THOUSAND PESOS
(P2,000.00) FROM OUT OF THE ITEM ON RURAL IMPROVE-
MENT UNDER AIDS AND TRANSFER OF FUNDS TO BE MADE
AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE
DEVELOPMENT AND IMPROVEMENT OF THE RESETTLEMENT
AREA FOR LAKE DANAQ SQUATTERS.

"WHEREAS, by virtue of the Memorandum dated June 2, 1973,
of the Office of the President, the Parks and Wildlife Office
has assumed jurisdiction over the Lake Danao area to initiate
measures to prevent destruction of the area by 'kaingeros' and
the like, and to clear the area of squatters and arrange for
their relocation or resettlement, for which this august Body
is duty bound to help said squatters in relocating or reset-
tling them outside of the area;

"NOW, THEREFORE, on motion of Councilor Samson, second-
ed jointly by Councilors Aviles, Kangleon and Marquez;

"RESOLVED, to revert the sum of two thousand pesos
(P2,000.00) from out of the item on rural improvement un-
der Aids and Transfer of Funds, said sum to be made avail-
able as supplemental appropriation for the development and
improvement of the resettlement area for the Lake Danao
squatters;

"RESOLVED, FURTHER, to furnish a copy of this resolu-
tion each to the Parks Superintendent, Parks and Wildfire
Station, the City Engineer, the City Treasurer, the City
Auditor, and the Barrio Council of Barrio Danao, all of
Ormoc City;

"CARRIED UNANIMOUSLY."
