RESOLUTION NO. 49

A RESOLUTION URGING AND SUPPORTING THE ORGANIZATION OF
THE LEAGUE OF PROVINCIAL VICE-GOVERNORS AND CITY
VICE-MAYORS OF THE PHILIPPINES AND PLEDGING PAR-
TICIPATION IN ITS FORTHCOMING CONVENTION AND ITS
OTHER ACTIVITIES

"WHEREAS, there is a move to organize the League of
Provincial Vice-Governors and City Vice-Mayors of the
Philippines even as there is a proposed national conven-
tion of the league to be held on March 23-24, 1973, in
the City of Manila;

"WHEREAS, the New Society and the New Constitution
of the Philippines have given emphasis to the imperative
need of strengthening units of local government as a
means of accelerating the realization of the objectives
of His Excellency, President Ferdinand E. Marcos;

"WHEREAS, the Provincial Governors and Board Members
have already organized their own separate and distinctive
groups;

"WHEREAS, the Provincial Vice-Governors and City
Vice-Mayors of the Philippines are fully aware of their
responsibility in meeting the challenged of the times
and are likewise determined to give their utmost coope-
ration to insure the success of the Republic under the
New Constitution;

"WHEREAS, there is a necessity for the Provincial
Vice-Governors and City Vice-Mayors to be better ac-
quainted with each other and exchange views and opi-
nions so that out of such common understanding they may
be united for cooperation;

seconded jointly by Councilors Mendola, Tan and Mejia;




