RESOLUTION NO. 53

A RESOLUTION AUTHORIZING THE ORMOC ELECTRIC COMPANY TO  
INSTALL THREE (3) STREET LIGHTS AT THE SOUTHERN POR-  
TION OF CAN-ADIENG RELOCATION CENTER FOR SQUATTERS  
AND THE CITY TREASURER TO RELEASE FUND OUT OF THE  
ITEM ON STREET LIGHT FIXTURES UNDER CAPITAL OUTLAYS  
FOR THE PURPOSE.

"WHEREAS, Councilor Aviles reported that during the  
inspection conducted by the Ormoc City Squatters Commit-  
tee it has been discovered that the southern portion of  
Can-adieng relocation center really needs some lighting;

"NOW, THEREFORE, on motion of Councilor Aviles, se-  
conded jointly by Councilors Mendola and Marquez;

"RESOLVED, to authorize the Ormoc Electric Company  
to install three (3) street lights at the southern por-  
tion of Can-adieng relocation center for squatters and do,  
as this Body hereby does, likewise, authorize the City  
Treasurer to release fund out of the item on street light  
fixtures under Capital Outlays for this purpose;

"RESOLVED, FURTHER, to furnish a copy of this reso-  
lution each to the Resident Manager, Ormoc Electric Co.,  
Inc., the City Treasurer and the City Auditor, all of  
Ormoc City;
