RESOLUTION NO. 55

A RESOLUTION REVERTING THE AGGREGATE SUM OF FOUR THOUSAND
THREE HUNDRED EIGHTY-TWO PESOS AND TWENTY-NINE CENTAVOS
(P4,382.29) FROM OUT OF SAVINGS OF THE WATERWORKS SYSTEM
TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR
COMPLETION OF THE WATERWORKS IMPROVEMENT PROJECTS.

"WHEREAS, the Waterworks Superintendent in his letter
dated March 13, 1973, has requested this august Body for
reversion of the aggregate sum of four thousand three hun-
dred eighty-two pesos and twenty-nine centavos (P4,382.29)
from out savings of his department, more particularly,
Items Nos. 10, 11 and 19, to finish the improvement pro-
jects of the Ormoc Waterworks System in view of the fact
that they have already spent a considerable portion of
the appropriation for improvement projects in the exten-
sion of pipelines to the resettlement area for squatters
in Barrio Can-adieng;

"NOW, THEREFORE, on motion of Councilor Samson, se-
conded by Councilor Porcadilla;

"RESOLVED, to revert the aggregate sum of four thou-
sand three hundred eighty-two pesos and twenty-nine cen-
tavos (P4,382.29) from out of the following items of the
Waterworks System, to wit:


