RESOLUTION NO. 56

A RESOLUTION AUTHORIZING THE CITY ASSESSOR TO SEGREGATE THE AREA OF 3,150 SQUARE METERS FROM OUT OF CITY LOT NO. 8372 SITUATED AT BARRIO CAGBUNANGIN TO BE MADE AVAILABLE FOR SCHOOL SITE OF SAID RARRIO AS IT IS NOW ACTUALLY OCCUPIED BY CAGBONANCIN SCHOOL STE.

"WHEREAS, the Barrio Captain of Cagbangin has, through the Committee on Public Properties, called the attention of this Board that the portion covering 3,150 square meters supposed to have been parcelled out from Lot No. 8372 of the City government for purposes of the community school site of Barrio Cagbuhangin, as per Resolution No. 88 dated June 11, 1969, of the Sixth Manicipal Board, was instead parcelled out from Lot No. 10012 which does not belong to the City but, nevertheless, the parrio school site of Bagbuhangin is actually occupying 3.10 square meters of City Lot No. 8372 whereby the school teacher of Caybuhangin made representations that this portion be segregated from the portion leased to the Philippine Sugar Institute and to be more particularly described as follows: institute and to be more particularly described as follows:

portion of Lot No. 8372 of the Ormoc Cadastre, belonging to the Government of Ormoc City, bounded on the North by Cagbuhangin Creek; on the East by Lot No. 10012 (part) and Juana Cawaling; on the South by Serafica private road; and on the West by the City Government Lot, said portion covering an area of three thousand one hundred fifty (3,150) square meters, more or less, to be segregated for purposes of the community school site of Barrio Cagbuhangin, Ormoc City;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded by Councilor Tan;

"RESOLVED, to authorize the City Assessor to segregate the area of 3,150 square meters from out of Lot No. 8372 of the Government of Ormoc City sitated at Barrio Cagbuhangin, said portion to be made available for school site of said barrio as it is now actually occupied by Cagbuhangin school site, as more particularly described above;
