RESOLUTION NO. 57

A RESOLUTION REVERTING THE SUM OF ONE HUNDRED FIFTY PESOS (P150.00) FROM OUT OF THE ITEM ON RURAL IMPROVEMENT UNDER AIDS AND TRANSFER OF FUNDS TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION TO PAY NEW ORMOC HARDWARE AND RADIO CENTER FOR 15 SHEETS OF CORRUGATED GALVANIZED IRON USED IN ROOFING SAN VICENTE COMMUNITY SCHOOL BUILDING.

"WHEREAS, the proprietress of the New Ormoc Hardware and Radio Center has presented her voucher amounting to one hundred fifty pesos (P150.00) for the 15 sheets of corrugated galvanized iron used in roofing the San Vicente Community School building;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Tan;

"RESOLVED, to revert the sum of one hundred fifty pesos (P150.00) from out of the item on rural improvement under Aids and Transfer of Funds, said sum to be made available as supplemental appropriation to pay the New Ormoc Hardware and Radio Center for 15 sheets of corrugated galvanized iron used in roofing the San Vicente Community School building;
