RESOLUTION NO. 1001

A RESOLUTION AUTHORIZING THE CITY LEGAL OFFICER TO FILE ACTIONS
AGAINST THE PHILIPPINE EAGLE BUS LINE FOR EREACH OF CONTRACT
AND VARIOUS VIOLATIONS OF CITY ORDINANCES AND FOR COLLECTION
OF RENTALS IN ARREARS AND CURRENT FOR THE
ORMOC CITY BUS TERMINAL

"WHEREAS, despite several warnings the Philippine Eagle Bus line has repeatedly violated its contract with the Government of Ormoc City and, also, in spite of repeated demands the PEEL could not produce the contract in connection with the use of the Ormoc City Bus Terminal;

"WHEREAS, the Philippine Eagle Bus Line used to occupy one-half bay of the bus terminal and sometime in or about February the company requested reduced rentals as it had only a very few units in operation to which the City, in good faith, acceded only to discover later in April upon checking up that its number of units has tremendously increased which accounted for twenty-one (21) trips a day leaving the City at a loss by three times less than what it ought to derive in revenue from the PEBL operations;

"WHEREAS, on top of it all, the Philippine Eagle Bus Line has purposely not paid its monthly rentals for the use of the bus terminal for the months of April, May and June, including the current month, where it should have paid its monthly rentals in advance as stipulated in the contract;

"WHEREAS, the Philippine Eagle Bus Line has been constantly and arrogantly violating city ordinances, more particularly, on regulations for dispatchers where the PEBL has never complied with, and on parking where the PEBL continuously double-park its buses along Lilia Avenue in wanton disregard for traffic safety;

"WHEREAS, the City Government has no other recourse than to avail itself of the services of the City Legal Officer with the view to filing necessary actions against the Philippine Eagle Bus Line based on the facts and circumstances mentioned above;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to authorize the City Legal Officer to file actions against the Philippine Eagle Bus Line for breach of contract and various violations of city ordinances and for collection of rentals in arrears and current for the use of the Ormoo City Bus Terminal; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Legal Officer and the City Fiscal, both in the City of Ormoo;
