A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE  
DEED OF SALE WITH ATTY. AND MRS. HELIODORO T. FIEL COVERING  
5,000 SQUARE METERS MORE OF THE LATTER'S LOT NO. 1631 FOR  
PURPOSES OF THE SQUATTERS RELOCATION CENTER IN BARANGAY PATAG

"WHEREAS, there is now being prepared another deed of sale with  
Atty. and Mrs. Heliodoro T. Fiel to be signed by the Honorable City  
Mayor covering 5,000 square meters more of the latter's Lot No. 1631  
situated in Barangay Patag for purposes of the relocation center for  
squatters at the same rate of P3.00 per square meter;
