UNITS OF AMBULANCE CARS TO THE ORMOC GENERAL HOSPITAL

"WHEREAS, the Chief of the Ormoc General Hospital has requested the intercession of this august Body with the Chairman of the Philippine National Charity Sweepstakes Office for the latter to donate two (2) units of ambulance cars to the Ormoc General Hospital for the transport of patients from the municipalities of Albuerge, Kananga, Matag-ob and Merida which are being served by the said hospital, including this city of Ormoc;

"WHEREAS, this Honorable Body finds the request of the Chief of Hospital most worthy of consideration taking into account the old ambulance car donated by the PNCSO in 1961 which had already been condemned as beyond economic repair and, therefore, disposed of as junk and transferred to Tacloban City National Manpower and Development Council Regional Training Center;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Chairman of the Philippine National Charity Sweepstakes Office to kindly donate two (2) units of ambulance cars to the Ormoc General Hospital; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Manager, Philippine National Charity Sweepstakes Office, Metro Manila; the Regional Director, Ministry of Health, Tacloban City; and the Chief, Ormoc General Hospital, Ormoc City;
