APPERTAINING TO THE SANGGUNIANG PANLUNGSOD NG ORMOC

"WHEREAS, the Honorable Jose C. Aviles, Vice-Mayor and Presiding  
Officer, will soon be out for a long while being a participant of the  
USAID Study Grant in the United States under the auspices of the Rural  
Service Center and the United States Assistance for International De-  
velopment (USAID) so much so that this august Body deems it wise and  
proper to authorize one of its Members to perform his duties as Pre-  
siding Officer hereof and to officially act on matters affecting the  
Sangguniang Panlungsod ng Ormoc such as signing payrolls, vouchers,  
purchase requests, daily time records, leave applications and other  
official functions as head of the city legislature and the secretariat;
