RESOLUTION NO. 1016

A RESOLUTION URGENTLY REQUESTING THE HONORABLE COMMISSIONER OF  
NATIONAL TELECOMMUNICATIONS THAT FUTURE PUBLIC HEARINGS ON THE  
ORMOC CITY TELEPHONE COMPANY'S APPLICATION TO INCREASE ITS  
RATES BE CONDUCTED IN ORMOC CITY AND IN NO WAY SHALL SUCH  
HEARINGS BE MOVED OR TRANSFERRED TO ANY OTHER VENUE FOR  
THE BENEFIT OF THE TELEPHONE SUBSCRIBERS OF ORMOC CITY

"WHEREAS, the Ormoc City Telephone Company has applied with the  
National Telecommunications Commission for an increase of its rates  
and not one among the telephone subscribers, much less this august  
Body, appeared during its hearing which might be construed by the  
Honorable Commissioner that nobody objects to such a raise to be  
imposed by the Ormoc City Telephone Company;

"WHEREAS, it would be to the greater benefit and welfare of the  
telephone subscribers in particular and the City of Ormoc in general  
if future hearings of the case were to be conducted in Ormoc City,  
where subscribers concerned would not have to spend for travel and  
transportation back and forth Metro Manila;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by  
Kagawad Bandalan; be it

"RESOLVED, to urgently request the Honorable Commissioner of  
National Telecommunications that future public hearings on the Ormoc  
City Telephone Company's application to increase its rates be conduct-  
ed in the City of Ormoc and in no way shall such hearings be moved or  
transferred to any other venue for the benefit of the telephone sub-  
scribers of Ormoc City; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each  
to Hon. Ceferino S. Carreon, Commissioner of National Telecommunica-  
tions, Metro Manila (Quezon City); the City Legal Officer and Engr.  
Salvador U. Socrates, General Manager, Ormoc City Telephone Co.,  
both in Ormoc City;

"CARRIED UNANIMOUSLY".
