RESOLUTION NO. 1017

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE OFFER OF THE EVTRANCO AND THE JD BUS LINE TO JOINTLY RENT THE FOUR OFFICE SPACES AT P800.00 PER MONTH AND THE ADJACENT LANES AT P1,500.00 PER LANE OR HALF-BAY PER MONTH AT THE ORMOG CITY BUS TERMINAL BUILDING NO. 2

"WHEREAS, the Honorable Kagawad Dionisio S. Santiago, in his capacity as Chairman of the Special Committee on Public Buildings Evaluation, reported that in the public hearing or conference with the bus operators this morning for the use of the Bus Terminal Building No. 2 including the office spaces starting August 1, 1981, only the EVTRANCO and the JD Bus Line signified their intention to rent the office spaces and the adjacent lanes on monthly basis while the others were interested only in paying their fees by the trip or daily basis;

"WHEREAS, the operators of both the EVTRANCO and the JD Bus Line have offered to jointly rent the four office spaces of Terminal Building No. 2 at the rate of P800.00 per month and the adjacent lanes at P1,500.00 per lane or half-bay per month and they are willing to enter into a yearly contract with the City Government in that connection

"WHEREAS, this august Body finds the offers of the EVTRANCO and the JD Bus Line most worthy of consideration;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly by Mga Kagawad Torrevillas, Bandalan and Hermosilla; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the offer of the EVTRANCO and the JD Bus Line to jointly rent the four office spaces at P800.00 per month and the adjacent lanes at P1,500.00 per lane or half-bay per month at the Ormoc City Bus Terminal Building No. 2; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and the bus operators of EVTRANCO and the JD Bus Line, wath all in the City of Ormoc; "CARRIED UNANIMOUSLY."
