A RESOLUTION ADOPTING RESOLUTION NO. 946 OF THE HONORABLE

"WHEREAS, the Honorable Sangguniang Panlungsod ng Cebu has furnished this august Body a copy of its Resolution No. 946 for our endorsement, and which we would like to adopt, requesting His Excellency, President Ferdinand E. Marcos, as Chairman of the Reorganization Commission recently created by him, to include in his government revamp scheme the possibility of returning the control, supervision and direction of the police forces of urbanized cities to their respective local governments;

"NOW, THEREFORE, on joint motion of Mga Kagawad Torrevillas and Santiago, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to adopt Resolution No. 946 of the Honorable Sangguniang Panlungsod ng Cebu and do, as this Body hereby does, request His Excellency, President Ferdinand E. Marcos, to include in his government revamp scheme the possibility of the police forces of urbanized cities to their respective local governments; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, Manila, and the Honorable Sangguniang Panlungsod, Cebu City;
