"WHEREAS, the Chair reported that his attention was called by the Honorable Mayor in connection with the allocation of lots in Barangay Patag relocation center for the squatters of the Ormoc City Central School property such that some of the allocatees might not be bona fide residents of the area whereby it becomes urgent to create a screening committee to investigate, screen and verify whether they are really squatters of the place;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded jointly by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to create a Special Screening Committee for Squatters to be allocated lots in the relocation center at Barangay Patag, said committee to compose the following: (a) a representative of the Mayor (b) the Barangay District XVIII Chairman, Mr. Antero T. Fiel (c) Hon. Benjamin F. Tugonon (d) Hon. Cristobal S. Mendola and (e) Hon. Cesar S. Samson; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Benjamin F. Tugonon, Hon. Cristobal S. Mendola, and Hon. Cesar S. Samson of the Sangguniang Panlungsod, and Mr. Antero T. Fiel, Barangay District XVIII Chairman, all in the City of Ormoc;
