RESOLUTION NO. 1028

A RESOLUTION EARNESTLY REQUESTING LEYECO V TO IMPLEMENT THE REDUCTION OF RATES TO P0.65 PER KILOWATT-HOUR EFFECTIVE OCTOBER 1, 1981, CONSIDERING THAT THE LOSSES INCURRED DURING THE USE OF THE ORMOC ELECTRIC COMPANY POWER SHALL HAVE ALREADY BEEN MORE THAN FULLY COVERED.

"WHEREAS, this august Body will remember the report of the Honorable Kagawad Santiago that upon his representations with the LEYECO V Management he was able to gather that the losses incurred by the cooperative due to the full use of the Ormoc Electric Company power will be fully recovered by the end of September, 1981, after having been absorbed by the consumers;

"WHEREAS, this Body has been made to believe by the LEYECO V management that upon recovery of such losses the electric current rates will be reduced or restored to P0.65 per kilowatt-hour as what the consumers have been enjoying until early last year prior to the breakdown of the Tuñongan geothermal pilot plant;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request LEYECO V to implement the reduction of rates to P0.65 per kilowatt-hour effective October 1, 1981, considering that the losses incurred during the full use of the Ormoc Electric Company power shall have already been more than fully recovered; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Col. Pedro Dumol, Administrator, NEA, Quezon Ave., Quezon City; the General Manager and the Board President, LEYECO V, both in Ormoc City;

"CARRIED UNANIMOUSLY."
