RESOLUTION NO. 1029

A RESOLUTION TO FORMULATE POLICIES FOR THE RELOCATION OF SQUATTERS

"WHEREAS, it is about time to establish a set of policies governing the relocation of squatters for a definite guideline for any committee to be created for the purpose considering that every time there is a relocation project we have to create a committee specially for the said purpose which committee has to adopt its own policies;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to formulate policies for the relocation of squatters definitely as follows:

- (1) Only bona fide residents at the government lot shall be considered as an allocatee;
- (2) One lot at the relocation site shall be reserved or set aside for the actual owner of a house at the public lot;
- (3) Any recipient of a lot at the relocation site shall be disqualified to be an allocatee in any future relocation site of the City of Ormoc;
- (4) The allocatee shall be made to pay for the lot, the cost of which shall depend on the actual cost paid by the City for every square meter plus the cost incurred for the development of the area, full payment of which shall entitle the said allocatee to a title of the lot allotted to him;
- (5) Allocatees shall observe and follow the rules and regulations governing the grant of local building permits;
- (6) The City Government shall only extend help to indigent squatters in the transfer of their houses to the relocation site;
- (7) The City Government shall deal without compassion and consideration on any squatting for speculation. Squatters who own houses in a government lot and use their houses for any other purpose than for their actual residence shall forfeit their respective rights for a relocation site;

(8) For a squatter who owns more than one house in any government lot being squatted on shall deserve only one (1) lot in the relocation sit provided he does not own any piece of lot within the City of Ormoc.
