RESOLUTION NO. 917

A RESOLUTION TO RECOMMEND THE GRANT OF REPRESENTATION ALLOWANCE
AS PROVIDED FOR IN THE CURRENT CITY BUDGET FOR THE CITY BUDGET
OFFICER TO THE HONORABLE MINISTER OF LOCAL GOVERNMENT AND
COMMUNITY DEVELOPMENT THE POSITION BEING THAT OF A DEPARTMENT
HEAD AS DEFINED UNDER SECTION 8 OF P.D. 1136 AND AS
ENVISIONED UNDER SECTION 4 OF LOI 1039

"WHEREAS, Section 4 of Letters of Instruction No. 1039 states that
the City Budget Officer, among others, shall have the rank of a depart-
ment head as defined under Section 8 of Presidential Decree No. 1136;

"WHEREAS, in the light of the foregoing provision of law, this au-
gust Body has duly considered the inclusion in the city budget of an
item on representation allowance for our City Budget Officer consider-
ing the position to be of equal rank with other city officials in ac-
cordance with Memorandum Circular No. 437 dated February 22, 1971, of
the Office of the President;

"WHEREAS, the City Budget Officer cannot avail herself of the rep-
resentation allowance without a recommendation from this Body;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kaga-
wad Tugonon; be it

"RESOLVED, to recommend the grant of representation allowance as
provided for in the current city budget for the City Budget Officer to
the Honorable Minister of Local Government and Community Development
the position being considered as that of a department head as defined
under Section 8 of Presidential Decree No. 1136 and as envisioned un-
der Section 4 of Letters of Instruction No. 1039; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Honorable Minister of Local Government and Community Development,
Quezon City, and the City Budget Officer, Ormoc City;

"CARRIED UNANIMOUSLY."
