RESOLUTION NO. 918

A RESOLUTION EARNESTLY REQUESTING THE DIRECTOR OF LANDS TO SET ASIDE
FOR ORMOC CITY GOVERNMENT NURSERY THE 20-HECTARE PORTION OF LAND
ABUTTING BETWEEN CAMBANTUG AND CABINGTAN, ORMOC CITY, AS TECHNI-
CALLY DESCRIBED IN THE ATTACHED SKETCH MAP.

"WHEREAS, the City Government of Ormoc is now bent on putting up
its nursery project on a portion of land abutting between Cambantug
and Cabingtang with an aggregate area of twenty (20) hectares as tech-
nically described in the attached sketch map;

"WHEREAS, this nursery project is a commitment of the City Admi-
nistration to the good people of Ormoc as it will alleviate the plight
of poor farmers and vegetable vendors;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly
by Mga Kagawad Bandalan and Santiago; be it

"RESOLVED, to earnestly request the Director of Lands to set aside
for Ormoc City Government Nursery the 20-hectare portion of land abutting
between Cambantug and Cabingtang, Ormoc City, as technically described in
the attached sketch map; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Director of Lands, Metro Manila; the Regional Director of Lands,
Tacloban City; and the City Assessor, Ormoc City;
