RESOLUTION NO. 919

A RESOLUTION EARNESTLY REQUESTING THE PC REGIONAL COMMANDER TO
AUTHORIZE THE FOUNDATION FOR THE REHABILITATION & PREVENTION
OF BLINDNESS IN THE PHILIPPINES, INCORPORATED, TO HOLD A 3-DAY
"PINTAKASI" (FEBRUARY 26-28, 1981) AT THE MADUNGHOLAN COCKPIT
IN ORMOC CITY TO SUPPLEMENT ITS FUND RAISING ACTIVITIES TO
SUSTAIN THE ORGANIZATION AND CARRY ON ITS LAUDABLE OBJECTIVES

"WHEREAS, the Office of the City Mayor has forwarded to this august
Body for appropriate action the communication of the Region VIII Coordi-
nator of the Foundation for the Rehabilitation & Prevention of Blindness
in the Philippines, Incorporated, dated January 11, 1981, requesting as-
sistance in the prosecution of their fund raising project by holding a
three-day 'pintakasi' from the 26th to the 28th of next month in order
that they could sustain the organization and carry on its objectives
from out of the proceeds thereof;

"WHEREAS, this august Body finds the request noteworthy considering
the Foundation's magnitude of aid to the handicapped;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kagawad
Tugonon; be it

"RESOLVED, to earnestly request the PC Regional Commander to author-
ize the Foundation for the Rehabilitation & Prevention of Blindness in
the Philippines, Incorporated, to hold a three-day 'pintakasi' on Febru-
ary 26, 27 and 28, 1981, at the Madungholan Cockpit, a duly licensed es-
tablishment, in Ormoc City, to supplement its fund raising activities to
sustain the organization and carry on its laudable objectives; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
PC Regional Commander and the PC Provincial Commander, both in Camp Sep-
tember 21st, Tacloban City; the Commanding Officer, 352nd PC Co., Camp
Downes, and the Manager, Madungholan Cockpit, both in Ormoc City; and
also the Regional Coordinator, Foundation for the Rehabilitation & Pre-
vention of Blindness in the Philippines, Incorporated, Tacloban City;
