RESOLUTION NO. 920

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, MONSIGNOR  
CIPRIANO URGEL, BISHOP OF THE DIOCESE OF PALO, LEYTE,  
FOR THE RETENTION OF MONSIGNOR FELIMON QUIANZON AS  
PARISH PRIEST OF ORMOC CITY.

"WHEREAS, it has come to the knowledge of this august Body  
that incumbent Parish Priest of Ormoc City, Rt. Rev. Msgr. Felimon  
Quianzon is due for transfer to another parish, that consequently,  
another priest will take his place in the Ormoc Parish;

"WHEREAS, Msgr. Quianzon, has been with us for about eleven  
years now and that for the whole period of his stay in Ormoc, he  
has done a lot of improvement in both the social and religious  
life of the Ormocanons;

"WHEREAS, we find in the person of Msgr. Quianzon, the sterling  
qualities of leadership not only in the propagation of the  
faith but also in the social field; thus, he was able to forge  
unity, cooperation, and understanding among his parishioners, his  
peers and even among the leaders of government in this city, and  
for these reasons he has carved a niche in the heart of every  
religious loving Ormocano;

"WHEREAS, Msgr. Quianzon, has done great works and wonderful  
task, in bringing about our catholic apostolicity in Ormoc  
and even in our neighboring towns, such that to transfer him to  
another place will cause not only a great loss of a distinguished  
and esteemed religious leader but also make Ormoc bereft of a parish  
priest, whom we have learned to love, respect and honor;

"WHEREAS, at present there are unfinished church projects  
being undertaken, as a joint venture of the church and of the  
people which necessitate his untiring efforts and guidance;

"NOW, THEREFORE, on motion of Mga Kagawad Tugonon, Besabella,  
and Santiago, unanimously seconded by all the other Mga Kagawad;  
be it



"RESOLVED, to earnestly request His Excellency, Monsignor Cipriano Urgel, Bishop of the diocese of Palo, Leyte, to retain Monsignor Felimon Quianzon as Parish Priest of Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution to Rt. Rev. Msgr. Quianzon, Ormoc City.
