RESOLUTION NO. 921

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EXTEND THE  
DEADLINE FOR PAYMENT OF MAYOR'S PERMIT FEES AND CITY  
LICENSES FROM JANUARY 20 TO JANUARY 31, 1981

"WHEREAS, there are numerous requests coming from the tax-  
payers that the deadline for payment of Mayor's permit fees  
and City Licenses be extended to January 31, 1981;

"WHEREAS, the request partakes of a temporary suspension  
of operation of Section 1.2.1.4 of Tax Ordinance No. 1, other-  
wise known as the Ormoc City Revenue Code, fixing the first  
20 days of January to pay tax obligations;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded  
by Kagawad Mendola; be it

"RESOLVED, to authorize the City Treasurer to extend dead-  
line for payment of Mayor's Permit fees and City Licenses from  
January 20 to January 31, 1981, suspending for this purpose  
temporarily Section 1.2.1.4. of Tax Ordinance No. 1, otherwise  
known as the Ormoc City Revenue Code; and be it

"RESOLVED, FURTHER, to furnish a copy of the resolution  
each to the City Treasurer and his City Licenses clerks, Ormoc  
City;
