RESOLUTION NO. 922

A RESOLUTION TO IMPLEMENT THE FOOD PRODUCTION PROGRAM OF THE "PAGKAIN NG BAYAN" LAUNCHED BY THE HONORABLE FIRST LADY AND HUMAN SETTLEMENT MINISTER, MADAM IMELDA ROMUALDEZ-MARCOS, TO BE INTEGRATED WITH OUR VEGETABLE NURSERY FARM AT CANBANTUG, MILAGRO, ORMOC CITY.

"WHEREAS, this august Body is in receipt of the telegram of Deputy Executive Director Nicolas Fernandez, thru the Honorable City Mayor, dated January 19, 1981, authorizing City Mayors to participate in the First Lady Food Production Program of the 'Pagkain ng Bayan';
