RESOLUTION NO. 928

A RESOLUTION GRANTING THE THREE FISCALS A REPRESENTATION ALLOWANCE EACH PURSUANT TO PD 1275 AND AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION IN THE LAW DEPARTMENT FOR THE PURPOSE.

"WHEREAS, the First Assistant City Fiscal, in his letter dated January 26, 1981, has requested the appropriation of a certain sum from savings of the Law Department, to be made available for representation allowance granted to the three (3) fiscals in his department, effective January, 1981;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Mendola, be it

"RESOLVED, to grant representation allowance to the three Fiscals, in pursuance of Presidential Decree No. 1275, and do, as this Body hereby does, authorize the City Treasurer to charge against current appropriation on representation allowance in the Law Department effective January, 1981, as follows:

- a) City Fiscal . . . . . ₱ 350.00 a month
- b) First Asst. City Fiscal . . . 300.00 a month
- c) 2nd Asst. City Fiscal . . . . 250.00 a month

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and the First Asst. City Fiscal, all in Ormoc City.
