RESOLUTION NO. 929

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION ON REPAIR OF GOVERNMENT BUILDING, EQUIPMENT, STAGE, FURNITURE, FIXTURES & OTHER FACILITIES UNDER THE OFFICE OF THE CITY TREASURER THE SUM OF THREE HUNDRED THIRTY-FIVE PESOS (P335.00) TO BE MADE AVAILABLE FOR THE REPAIR OF ONE (1) UNIT AIR-CONDITIONER IN THE OFFICE OF THE CITY BUDGET OFFICER.

"WHEREAS, the City Budget Officer in her letter of January 27, 1981, specifically last paragraph thereof, has requested for authorization of the City Treasurer to charge the repair of one (1) unit of air-conditioner presently used in the City Budget Office;

"NOW, THEREFORE, on motion of Kagawad Besabella jointly seconded by Kagawad Tugonon and Samson; be it

"RESOLVED, to authorize the City Treasurer to charge against current appropriation on Repair of Government Building, Equipment, Stage, Furniture, Fixtures & other Facilities under the Office of the City Treasurer, the sum of Three Hundred Thirty-Five Pesos (P335.00), said sum or so much thereof as may be necessary to be made available for the repair of one (1) unit of air-conditioner in the Office of the City Budget Officer; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and the City Budget Officer, all in Ormoc City;
