RESOLUTION NO. 936

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER OF  
PUBLIC HIGHWAYS, THRU THE REGIONAL DIRECTOR, TO CONSTRUCT  
THE ORMOC-JARO ROAD AND PROVIDE FUNDS THEREFOR, TO CONSERVE  
MUCH MORE ENERGY AND TO OPEN UP VAST FIELDS FOR IMPROVEMENT  
AND DEVELOPMENT IN ALL THE NEIGHBORING AREAS

"WHEREAS, it has been a long dream of the Ormocanos for a road  
opened to the municipality of Jaro in the eastern side of Leyte such  
that travel back and forth Tacloban would be shorter not only in dis-  
tance but also in time, and now that we are facing energy crisis the  
people are hoping for the realization of such a dream;

"WHEREAS, the construction of Ormoc-Jaro road will not only bols-  
ter our conservation of energy but also open up vast fields for improve-  
ment and development in all the neighboring areas which are well within  
the vicinities of the national parks and tourists spots of Tugonon Hot  
Springs and Lake Imelda;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unani-  
mously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Honorable Minister of Public  
Highways, through the Regional Director, to construct the Ormoc-Jaro  
Road and provide funds therefor inasmuch as the road will not only  
bolster the conservation of much more energy but also open up vast  
fields for improvement and development all around the neighboring  
areas of Tugonon Hot Spring and Lake Imelda; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the Honorable Minister of Public Highways, Metro Manila; the Regional  
Director of Public Highways, Paving, Palo, Leyte; the Honorable Mayor  
of Jaro, Leyte; and the City Engineer, Ormoc City;
