A RESOLUTION URGENTLY REQUESTING THE HONORABLE MINISTER OF SOCIAL SERVICES AND DEVELOPMENT FOR THE FEASIBILITY OF ESTABLISHING A JUVENILE HOME IN THE CITY OF ORMOC

"WHEREAS, it has become alarming to note that acts of truancy, waywardness and incorrigibility committed by juvenile delinquents of this city are on the rise which our police do not seem to cope with the situation even as these youngsters are reportedly staying away from their homes despite our curfew ordinance and sleep in markets and other public places after indulging themselves in rugby sessions while others take to the cover of darkness armed with Indian arrows or blowgun darts waylaying innocent people just for the thrill of it;

"WHEREAS, these acts, not to mention their hooliganism or vandalism committed out of their vagrancy and vagabondage could be minimized if not eliminated with the establishment of a juvenile home which may be managed under the auspices of the Ministry of Social Services and Development;

"NOW, THEREFORE, on joint motion of Mga Kagawad Samson and Torrevillas, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to urgently request the Honorable Minister of Social Services and Development for the feasibility of establishing a juvenile home in the City of Ormoc; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Social Services and Development, Metro Manila; the Regional Director, MSSD, Tacloban City; and the Officer In-Charge, MSSD, Ormoc City;
