RESOLUTION NO. 939

A RESOLUTION LIMITING PAYMENT BY THE CITY FOR ELECTRIC CURRENT CONSUMPTION FOR ONLY FIVE (5) UNITS OF INCANDESCENT OR MERCURY LAMPS FOR EVERY BARANGAY AND CONSUMPTION OF ANY UNIT IN EXCESS THEREOF SHALL BE PAID BY THE BARANGAY OUT OF ITS TEN PERCENT (10%) REALTY TAX SHARES OR FROM ANY OTHER SOURCE

"WHEREAS, with the extension of electric services by LETECO V to the barangays the latter are expected to put up electric lights on their streets and public buildings the current consumption of which they believe will be paid by the City Government;

"WHEREAS, for reasons of economy and energy conservation there should be a limit to the number of incandescent or mercury lamps to be charged to the city's accounts for installation in barangays to only five (5) units for every barangay and any unit in excess shall be shouldered by the barangays concerned from their 10% realty tex shares or any other source;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kagawad Tugonon; be it

"RESOLVED, to limit the payment by the City for electric current consumption for only five (5) units of incandescent or mercury lamps for every barancey and consumption of any unit in excess thereof shall be paid by the barangay out of its ten percent (10%) realty tax shares or from any other source of the said barangay; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the President and General Manager of LEYECO V, the City Treasurer, the City Auditor, and all Barangay Captains, Ormoc City; "CARRIED UNANIMOUSLY."
