RESOLUTION NO. 940

A RESOLUTION AMENDING RESOLUTION NO. 791 BY ASSIGNING THE
HONORABLE ROMEO M. HERMOSILLA, VICE PLACIDO C. ENECIO
(DECEASED), TO SANGGUNIAN REPRESENTATIVE DISTRICT V
WHICH IS TEMPORARILY REPRESENTED BY THE HONORABLE
CITY VICE-MAYOR AND PRESIDING OFFICER.

"WHEREAS, this Honorable Body will recall that with the untimely demise of a colleague, the Honorable Placido C. Enecio, Sanggunian District V was left bereft of a KAGAWAD IN CHARGE such that by general acquiescence of the Second Sangguniang Panlungsod ng Ormoc the Honorable City Vice-Mayor and Presiding Officer had been authorized to take charge of the District in a temporary capacity until such time that a reorganization will be in the offing;

"WHEREAS, the Honorable Romeo M. Hermosilla, who has joined this Body since July 15 of last year by virtue of his position as President of the Association of Barangay Councils, has not yet been assigned to specific barangays for his area of responsibility although he represents the ABC, such that he is being groomed to take charge of District V inasmuch as the Honorable City Vice-Mayor and Presiding Officer is relinquishing his temporary charge over the District;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Santiago; be it

"RESOLVED, to amend Resolution No. 791 by assigning the Honorable Romeo M. Hermosilla, vice Placido C. Enecio (deceased), to Sanggunian Representative District V which is temporarily represented by the Honorable City Vice-Mayor and Presiding Officer, said District composing the Barangays of Punta, Linao, Batman, Tambulilid, Nauñgan, San Isidro, Santo Niño, Libertad, To-og and Buenavista, Ormoc City; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Vice-Mayor and Presiding Officer, the Honorable Romeo M. Hermosilla, and all Barangay Captains of District V, Ormoc City;
