RESOLUTION NO. 943

A RESOLUTION TO AMEND RESOLUTIONS NOS. 561, 780, 796, AND 938
AND ALL OTHERS OF SIMILAR IMPORT APPERTAINING TO DONATION OF
MERCURY LAMPS BY AUTHORIZING THE HONORABLE CITY MAYOR
TO ACCEPT THE DONATIONS

"WHEREAS, upon a cursory review of our records it has been found out that some of the mercury lamps donated to the city have been accepted by this august Body without the benefit of an authority of the Honorable City Mayor to accept them as can be gleaned from our Resolutions No. 561 of the First Sangguniang Panlungsod regarding the donation of mercury lamps for installation on a subdivision street, on Rizal street and Navarro street, and No. 780 of this august Body on mercury lamps installed in Barangay District XXVII, No. 796 on the mercury lamp donated by the Iglesia Ni Kristo, and No. 938 on the mercury lamps donated by the Barangay Council of Cabulihan and Barangay District XIII;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Nga Kagawad Torrevillas and Bandalan; be it

"RESOLVED, to amend Resolutions Nos. 561, 780, 796 and 938, and all other resolutions of similar import appertaining to donation of mercury lamps by authorizing the Honorable City Mayor to accept the donations; and be it
