RESOLUTION NO. 944

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST  
CURRENT APPROPRIATION ON MANPOWER DEVELOPMENT PROGRAM THE  
SUM OF TWO HUNDRED SIXTY-SEVEN & 40/100 PESOS (P267.40)  
TO BE MADE AVAILABLE FOR SETTLING OUTSTANDING OBLIGATIONS  
WITH THE SAINT PETER'S COLLEGE ON ELECTRIC CURRENT CONSUMED  
BY THE LOCAL MANPOWER COUNCIL HOLDING CLASSES THEREAT

"WHEREAS, the Saint Peter's College has presented a city voucher  
claiming the sum of two hundred sixty-seven pesos and forty centavos  
for electric current consumed by the Local Manpower Council holding  
classes at the college from April to October, 1980;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by  
Kagawad Mendola; be it

"RESOLVED, to authorize the City Treasurer to charge against cur-  
rent appropriation on Manpower Development Program the sum of two hun-  
dred sixty-seven & 40/100 pesos (P267.40), said sum or so much thereof  
as may be necessary to be made available for settling outstanding obli-  
gations with the Saint Peter's College on electric current consumed by  
the Local Manpower Council holding classes at said college; and be it

the City Treasurer, the City Auditor, the Chairman of the Local Man-  
power Council; and the Directress of St. Peter's College, all in the  
City of Ormoc; including the City Budget Officer;
