RESOLUTION NO. 950

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO GRANT A PERMIT TO BARANGAY VALENCIA TO HOLD A THREE-DAY 'PINTAKASI' (APRIL 2-4, 1981) AT THE VALENCIA SPORTS CENTER FOR ITS LOGISTICAL SUPPORT TO THE SPORTS AND YOUTH DEVELOPMENT PROGRAM PROVIDED THE BARANGAY HAS THE NECESSARY PERMIT FROM THE PHILIPPINE CONSTABULARY TO HOLD SAID 'PINTAKASI'.

"WHEREAS, the Barangay Council of Valencia by its Resolution No. 1a, s. 1-1-81, has requested this august Body to grant the Barangay a permit to hold a 'pintakasi' for three days from 2 to 4 April 1981 at the Valencia Sports Center for the purpose of generating logistical support to the sports and youth development program;

"WHEREAS, the power to grant a permit for 'pintakasi' rests solely on the Office of the Mayor provided there is an authority from the Philippine Constabulary to hold such cockfights;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded jointly by Mga Kagawad Samson and Hermosilla; be it

"RESOLVED, to authorize the Honorable City Mayor to grant a permit to Barangay Valencia to hold a three-day 'pintakasi' on April 2, 3 and 4, 1981, at the Valencia Sports Center, for its logistical support to the sports and youth development program; PROVIDED, HOWEVER, That the necessary authority is secured from the Philippine Constabulary to hold such 'pintakasi'; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional and the Provincial PC Commanders, both in Camp September 21st, Tacloban City; the Commanding Officer, 352nd PC Company, the Barangay Captain and the Proprietor of the Sports Center, both in Barangay Valencia, and all in the City of Ormoc;
