RESOLUTION NO. 952

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR OF FOREST DEVELOPMENT, THROUGH THE LOCAL OFFICER-IN-CHARGE, TO DEPUTIZE ALL THE BARANGAY CAPTAINS OF ORMOC CITY AS FOREST GUARDS.

"WHEREAS, this august Body firmly believes that illegal logging in the City of Ormoc could be minimized if not eradicated if only barangay officials, most specially barangay captains, would be deputized as forest guards inasmuch as the Bureau of Forest Development is so undermanned that it cannot cope with the rampant cutting of timber by undesirable loggers;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Regional Director of the Bureau of Forest Development, through the local Officer-In-Charge, to deputize all the barangay captains of Ormoc City as forest guards; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Director, Bureau of Forest Development, Metro Manila; the Regional Director, Bureau of Forest Development, Tacloban City; and the Officer-In-Charge, Bureau of Forest Development, Ormoc City;
